

## ***WIDA Assessment Irregularities***

Testing irregularities are misadministrations or procedural errors that may require action by the district, MDE, and/or DRC. This guidance outlines common scenarios and typical outcomes; however, final decisions may vary based on individual circumstances.

### **Requesting Support**

If English learner (EL) program staff initiate contact, MDE will ensure the District Assessment Coordinator (DAC) is included in the communication.

### **Regenerations and Invalidations**

A regeneration allows a student to restart a domain test when an irregularity has significantly interfered with testing (for example, a required accommodation was not provided). MDE approves regenerations only when test validity is maintained and no unfair advantage is given.

An invalidation ends all remaining testing for a domain and results in an INV code. It is used when test integrity is compromised or when a student gains an unfair advantage.

### **Regeneration Request Process**

To request a regeneration, the DAC must notify MDE and include the following:

- The student's MARSS/SSID number (do not include the student's name or other personally identifiable information)
- A clear description of the irregularity
- The affected domain test(s)

If approved, MDE will contact DRC and copy the DAC on the communication.

### **Test Administration Reports**

Many irregularities require documentation on the *Test Administration Report* (TAR), available in Appendix A of the [Procedures Manual](#). TARs are used to document incidents, support district-level tracking, and inform future training, scheduling, and monitoring efforts.

Note: If the incident involves a security concern, the DAC must submit an Assessment Security Record (ASR) in [Test WES](#).
