| <b>Process Overview</b> | <p>As students enroll for the first time in any BIE-funded school, they should be administered a Home Language Survey (HLS).</p> <p>If a language other than English is noted, the student should be administered one of the following WIDA identification assessments located within the <a href="#">WIDA Secure Portal</a></p> <ul style="list-style-type: none"> <li>• WIDA Screener for Kindergarten</li> <li>• WIDA Screener Online Grades 1-12</li> <li>• WIDA Screener Paper Grades 1-12 (for purchase by school)</li> </ul> |

| <b>Timelines</b>                  | <p>If students have been identified as eligible for EL services prior to the beginning of the school year, Title I law requires parental notification within 30 days after the beginning of the school year. Once the school year is underway, the window for identification, screening and parental notification of eligibility is within two weeks of enrollment.</p> <p>It is the expectation of BIE that students will be assessed as soon as logistically possible within appropriate time frames.</p> |
| <b>Home Language Survey</b>       | <p>The HLS is administered upon enrollment to determine the presence of other languages that may impact student academic performance.</p> <p>If one or more responses indicates a language other than English, students are given the appropriate state -adopted screening assessments noted above.</p> <p>BIE has a recommended HLS located on the <a href="#">BIE member page</a> of the WIDA website under the Agency Testing Requirements tab and on the BIE.edu website.</p>                           |
| <b>State Approved Assessments</b> | <p>Located in the <a href="#">WIDA Secure Portal</a></p> <ul style="list-style-type: none"> <li>• WIDA Screener for Kindergarten</li> <li>• WIDA Screener Online Grades 1-12 (available through the <a href="#">WIDA Assessment Management System</a>)</li> <li>• WIDA Screener Paper Grades 1-12 (for purchase by school through the <a href="#">WIDA Store</a>)</li> </ul> <p>For students with an IEP or 504, follow the guidance provided in the student plan.</p>                                      |

| <b>Test Administrator Training Requirements</b> | <p>All test administrators must be certified in assessments they will be administering.</p> <p><b>WIDA Screener (Online &amp; Paper)</b><br/>To be certified to administer WIDA Screener, test administrators must complete the following courses for the tests they will be administering:</p> <ul style="list-style-type: none"> <li>• WIDA Screener Online: Administration</li> <li>• WIDA Screener Paper: Administration</li> </ul> <p>To be certified to score WIDA Screener, test administrators must complete the following courses for the grade level tests and domains they will be scoring:</p> <ul style="list-style-type: none"> <li>• Speaking for Grades 1-5: Scoring ACCESS Paper and WIDA Screener</li> <li>• Speaking for Grades 6-12: Scoring ACCESS Paper and WIDA Screener</li> <li>• Writing for Grades 1-5: Scoring WIDA Screener</li> <li>• Writing for Grades 6-12: Scoring WIDA Screener</li> </ul> <p><b>Recertification policy:</b> WIDA recommends annual recertification for WIDA Screener Speaking and Writing.</p> <p><b>WIDA Screener for Kindergarten:</b> To be certified to administer WIDA Screener for Kindergarten, test administrators must complete the WIDA Screener for Kindergarten: Administration and Scoring training course, located in the <a href="#">WIDA Secure Portal</a> and pass the relevant certification quizzes.</p> |
