Questions/Topic	State-specific Guidance
Process Overview	<p>During registration, all students entering school in Virginia are required to answer three identifying questions developed by the U.S. Department of Education and U.S. Department of Justice which are included verbatim on registration documents or on a separate Home Language Survey provided to all students enrolling in a division. If a parent or guardian responds with any language other than English for one or more questions below, then the student is progressed to the language screening process.</p> <ul style="list-style-type: none"> • What is the primary language used in the home, regardless of the language spoken by the student? • What is the language most often spoken by the student? • What is the language that the student first acquired?
Timelines	<p>For students who enroll at the beginning of the school year, divisions complete the screening and parent notification process within 30 calendar days of enrollment. For students who enter during the school year, the process must be completed within 14 calendar days.</p>

Initial Assessment and Identification

<p>Home Language Survey</p>	<p>Divisions administer the following questions verbatim to all students enrolling in a Virginia public school on registration documents or on a separate Home Language Survey:</p> <ul style="list-style-type: none"> • What is the primary language used in the home, regardless of the language spoken by the student? • What is the language most often spoken by the student? • What is the language that the student first acquired? <p>If a parent or guardian responds with any language other than English for one or more questions, then the student is progressed to the language screening process.</p> <p>Designated division personnel review registration and/or home language survey documents submitted to the school for educational information, language, and ELD assessment scores to determine the next steps. If a current ACCESS for ELLs score (within one year of testing) is provided, the score can be used to determine the student’s EL status and the services to be provided. If a current ACCESS for ELLs score is not provided, designated division personnel should ascertain if the student took the ACCESS for ELLs in the last year and follow up with that division in a timely manner or administer a WIDA screening tool to determine the student’s English proficiency level.</p>

	<ul style="list-style-type: none"> • throughout the kindergarten school year • as they enter first grade, until the end of the first semester of the school year. <p>In July 2021, WIDA convened a panel of early childhood education experts to provide recommendations regarding when and under what conditions WIDA Screener for Kindergarten should be administered to students in the spring prior to entering Kindergarten. Identification/Placement Criteria	<p>Recommended screening criteria are provided in Superintendent’s Memo 149-21: Required Entrance Procedures and Criteria for Identifying Potential English Learners. Other Useful Resources or Information	<p>Student Transfers: If it is determined that the student was administered an English language proficiency test while enrolled in a previous school, then staff should seek to obtain test results from the sending school to determine the student’s EL status.</p> <p>If a Home Language Survey was completed in another Virginia public school prior to enrolling at the current school, then staff should compare the response on the two forms for consistency. If inconsistencies are found, staff should determine if the student should be progressed to the language screening process.</p>

	<p>If documentation indicates the student is an EL, and if no documentation of the student’s English proficiency level is provided, then the student should be administered a WIDA screening instrument to determine an English proficiency level.</p> <p>WIDA Screener and ACCESS for ELLs scores should be entered in the division student information system by designated division personnel.</p> <p>Contact the VDOE Office of Student Assessment at student_assessment@doe.virginia.gov for assistance with determining the status of transferring ELs.</p>

Test Administrator Qualifications	Division test examiners who successfully complete the online WIDA Screener test administrator training in the WIDA Secure Portal and complete any local training required are qualified to administer the assessment(s).
Test Administrator Training Requirements	<p>WIDA Screener To be certified to administer WIDA Screener, test administrators must complete the following courses for the tests they will be administering:</p> <ul style="list-style-type: none"> • WIDA Screener Online: Administration • WIDA Screener Paper: Administration <p>To be certified to score WIDA Screener, test administrators must complete the following courses for the grade level tests and domains they will be scoring:</p> <ul style="list-style-type: none"> • Speaking for Grades 1-5: Scoring ACCESS Paper and WIDA Screener • Speaking for Grades 6-12: Scoring ACCESS Paper and WIDA Screener • Writing for Grades 1-5: Scoring WIDA Screener • Writing for Grades 6-12: Scoring WIDA Screener <p>WIDA Screener for Kindergarten Test administrators must complete the WIDA Screener for Kindergarten: Administration and Scoring training course and pass the following certification quizzes:</p> <ul style="list-style-type: none"> • WIDA Screener for Kindergarten: Oral Language • WIDA Screener for Kindergarten: Literacy <p>WIDA MODEL Test administrators should review the training CD/DVD and materials included in the assessment kit.</p> <p>Division test examiners must complete all training components, including quizzes/certification, annually.</p>

EL Program Requirements – Services & Support

Question/Topic	State-specific Guidance
EL Services or Program Requirements	<p>All identified ELs grades K-12 other than ‘parent refusals’ ELs must be placed in effective LIEP services. For divisions accepting Title III funds, the LIEP services are described in their annual Title III application.</p> <p>WIDA Screener Online results are stored in the WIDA AMS application. Enter student proficiency levels in the division Student Information System and code the appropriate Student Record Collection Data (Code 1 for identified ELs receiving services). See the Title III Program Website</p>
Declining Services	<p>Parents can decline LIEP services (‘parent refusals’) per division procedures. This should include a written and signed declaration of parental choice documenting that they have full understanding of the LIEP services that they have declined.</p> <p>Annual English language proficiency testing cannot be declined by parents. The division must have a process in place to monitor the academic progress of identified ELs who have declined LIEP services, and they must be provided the same academic programs and services as any student at risk for academic failure. The linguistic needs of these ELs must also be addressed within the general education program.</p>
