WIDA Alternate ACCESS yog ib qho kev xeem uas ua los rau cov tub ntxhais kawm qib kawm me nyuam yaus-qib 12 uas raug txheeb xyuas tias yog cov neeg kawm lus Askiv uas muaj kev xiam oob qhab loj tshaj plaws.

WIDA Alternate ACCESS ntsuas cov tub ntxhais kawm ntawv cov kev txawj lus Askiv hauv Kev Mloog, Kev Nyem Ntawv, Kev Hais Lus, thiab Kev Sau Ntawv.

Koj tus me nyuam raug txheeb xyuas tias yog ib tus neeg kawm lus Askiv uas txhais tau tias koj tus me nyuam tuaj yeem muaj cov kev pab cuam txhawb nqa hais lus Askiv, ntxiv rau kev kawm rau lwm chav kawm.Cov neeg kawm lus Askiv ua kev xeem rau kev paub lus Askiv zoo txhua xyoo.Muaj ntawv tus neeg kawm lus Askiv tau xeem ACCESS for ELLs.Lub laj thawj koj tus me nyuam xeem WIDA Alternate ACCESS tias yuav yog vim li cas

- Lawv tau raug txheeb xyuas tias muaj kev xiam oob qhab tseem ceeb loj.
- Lawv cov kws qhia ntawv xav tias WIDA Alternate ACCESS, uas muaj kev txhawb nqa ntxiv thiab cov cib fim los teb rau cov kev xeem, yuav ua rau lawv zoo tshaj plaws los qhia txog lawv cov kev txawj lus Askiv.



Kev Paub Ntaub Ntawv As Kiv

Qib kev paub lus Askiv yog qhov ntsuas ntawm qhov uas cov tub ntxhais kawm tab tom txhim kho cov kev txawj lus Askiv uas xav tau kom nkag mus rau cov ntsiab lus qhia ua lus Askiv tau. Thaum cov tub ntxhais kawm mus txog qib siab tshaj plaws ntawm kev paub lus Askiv zoo lawm, lawv tsis xav tau kev pab txhawb nqa lus los koom nrog cov ntsiab lus qhia uas yog lus Askiv.

WIDA Alternate ACCESS cov qhab nia yuav raug siv li cas?

Qhov kev xeem pab ua kom cov kws qhia ntawv nkag siab seb cov tub ntxhais kawm puas muaj kev txawj lus uas lawv xav tau los koom tag nrho nrog hauv chav kawm.Cov neeg kawm lus Askiv uas muaj kev xiam oob qhab **tuaj yeem** kawm lub lab npauv kev paub hom lus thiab kev sib txuas nyuaj.Koj tus me nyuam cov kws qhia ntawv siv cov qhab nias kev xeem WIDA Alternate ACCESS raws li lawv txiav txim siab txoj hau kev zoo tshaj plaws los qhia koj tus me nyuam.

- Nrog koj tus me nyuam cov kws qhia ntawv tham txog tias thaum twg koj yuav tau txais cov qhab nia xeem, koj tus me nyuam lub tsev kawm ntawv yuav siv cov qhab nia li cas, thiab koj tsev neeg yuav tuaj yeem txhawb nqa koj tus me nyuam txoj kev loj hlob lus hauv tsev tau li cas.
